FARO ALTERNATIVE INVESTMENTS UNVEILS THE 4 INVESTMENT SUB-FUNDS AND ANNOUNCES OVERALL FUNDING TARGET OF AROUND €1BN BY 2026

FARO is a virtuous ecosystem in which relationships, knowledge and skills act as an engine to generate new opportunities. Four sub-funds managed by Advisory Companies such as Orienta Capital Partners, FOREL, FNDX, SM Capital and IRTOP Consulting and a system of investment in small and medium-sized Italian companies, with a strong entrepreneurial approach.

Milan, November 13, 2024 – The meeting with the financial community of FARO Alternative Investments, the alternative investment fund operating through a globally active scalable platform with diversified investment strategies, was held today at Palazzo Mezzanotte, the headquarter of Borsa Italiana. The project was created to offer new investment opportunities on the Italian and international scene through a platform that combines different 'best in class' and complementary skills required in the management of large assets and Italian and foreign institutional investors.

The main objective of **FARO Alternative Investments** is to provide asset allocation diversification through an entrepreneurial approach, responding to the needs of structured asset management, in the landscape of institutional, private and family office investors.

Among its strengths, FARO expresses the strong potential for international development through an infrastructure capable of aggregating diversified expertise in a single platform.

The project is based on three fundamental pillars:













- 1. **Entrepreneurial** a key value for FARO, leveraging in-house operational experience based on know-how and track record.
- 2. **Attractive** thanks to an ecosystem supported by the best Italian and international professionals.
- 3. **Scalable** to allow the project to grow and attract more and more resources and expertise through a multi-compartment fund, structured in a plug-and-play fashion. This approach makes it possible to develop investment strategies and operate as an advisory company with 'best in class' expertise in the sector.

With an ambitious fundraising plan, FARO Alternative Investments aims to reach a total target of around **EUR 1 billion by 2026**, with which it aims to support the Italian entrepreneurial fabric, generating a significant impact in key sectors of the real economy.
